

LUKE HANKS II (Elizabeth Dale)
Son of Luke Hanks I and Elizabeth

Note: Separating Luke Hanks I from Luke Hanks II would explain some of the discrepancies in Baber's account of this family where he has combined the children of Luke Hanks I and II. It would explain the great gap (1722-1737) in the birth of sets of children, the Dale connection in Pr. Wm. Co. and the Harris/Harrison wife of Luke III.

Luke Hanks II (Jr.), (Luke I, William) was born about 1715 to have been at least 21 years old when he is first mentioned in court records of Richmond Co on 30 July 1736 when the claim of Luke Hanks Jr. of this county for taking up a runaway servant belonging to Sam Wiggins of Westmoreland Co. was filed.¹ Because Luke Hanks is mentioned in this record as Luke Hanks Jr. we know there were at least two Luke Hanks present in Richmond Co. records in 1736. This supports my theory that Luke Hanks Sr. died by 1743, when the Sr./Jr. designation was no longer mentioned in the records. This then, makes it likely Luke Hanks II (Jr.) was the father of the children born between 1737 and 1752. Luke II (Jr.) is placed as a child of Luke I because he does not fit in the family of William or John Hanks.

Luke Hanks II (Jr.), (Luke, William) married first Elizabeth (probably Dale, a daughter of Abraham and Winifred Southern Dale) and had the following children: Turner Hanks born 8 June 1737,² Luke Hanks born about 1739, Sarah Hanks born about 1741, Abraham Hanks born about 1743, Mary Hanks born about 1745, and Moses Hanks born about 1747. By wife Sarah he had Martha born 26 May 1752³. Elizabeth Dale was likely the daughter Ann born 2 April 1717 to Abraham and Winifred Dale as noted in NFP Registers Richmond Co. Va.

On 5 Aug 1740 action of trespass John Tarpley agst. Luke Hanks and on 1 June 1741 Leroy Griffin agst. Luke Hanks debt.⁴ On 4 July 1743 Thomas Plummer agst. Luke Hanks Jr. due by account from 3 July 1742.⁵ On 5 Sept 1743 Travers Colston agst. Luke Hanks Jr. debt.⁶ On 5 May 1746 James Gordon agst. Luke Hanks debt.⁷ (*on this same date James Gordon also sued Dawson Hanks.*) On 2 Sept 1751 ordered the churchwardens of NFP for the time being bind Lettice Hanks a bastard child of Sarah Hanks according to law.⁸ Note: (*This cannot be the same child as the one in 1727. The 1727 child would be at least 24.*)

On 11 Aug 1749 in Lancaster Co., Va. Henry Tapscott sued Luke Hanks for debt.⁹ On 14 December 1750 Bryan and Thomas Stott vs. estate of Luke Hanks def. attachment, judgment granted plts.¹⁰

On 20 November 1756 Tapscott came into court and made oath that Luke Hanks departed this life without making any will as far as he knows and on his motion and giving security for administration a certificated is granted for letters of adm., ordered Richard Miskell, John Rogers, Richard Rogers and John

Muse or any three of them appraise the estate of Luke Hanks.¹¹ On 15 April 1757 an appraisal and sale of the estate of Luke Hanks dec'd. was returned.¹² Often the largest creditor was awarded administration of an estate that contained a lot of debt.

The records after 1743 do not again refer to Luke Hanks II (Jr.) I believe Luke Hanks I (Sr.) died about 1743/1744 and Luke Hanks II (Jr.) is the one who died by November 1756, leaving his children orphans as shown by apprenticeship records of Abraham Hanks born 1743.

The children of Luke Hanks II and Elizabeth Dale include:

Turner Hanks (Luke II, Luke I, William) was born 18 June 1737¹³ and was likely the oldest child of Luke Hanks II and wife Elizabeth. On 4 Aug 1784 James Howard was granted administration of the estate of Turner Hanks.¹⁴ An appraisal of the estate of Turner Hanks dec'd was ordered on 6 Sept 1784.¹⁵ On 10 Aug 1787 motion of John Nash who married Molly a daughter of Turner Hanks dec'd. and James Howard adm. of sd. Hanks ordered Nash to have his wife's part of estate.¹⁶ The estate of Turner Hanks in account with James Howard adm. 7 Sept 1789.¹⁷

Turner Hanks was married twice. He and first wife Million or Millicent had Mary Hanks born 20 May 1761¹⁸ and Hannah Hanks born 3 June 1767.¹⁹ By second wife Sarah he had George Hanks born 22 June 1769,²⁰ Luke Hanks born 17 May 1771²¹, Rawleigh Hanks born 1 Apr 1773, Pitman Hanks born 3 Dec 1776, and Chichester Hanks born 31 May 1781.²² (See additional write up on family of Turner Hanks)

Luke Hanks III (Luke II, Luke I, William) born about 1739 and died 1789. A brother of Abraham Hanks, Luke migrated to Pr. William Co. at least by 1 January 1778 when he witnessed an indenture from Thomas Thornton of Pr. Wm to James Cullins of same land of S side Broad Run adj. Charles Thornton, James White and George Maddison part of the tract upon which the Tavern now stands cont. 70 ac. witness by Thomas Love, Robert Warren, Luke Hanks ack 4 May 1778²³ On 13 June 1778 (Broad Run

Baptist Church Fauquier Co., VA. records) Nancy Hanks was added by baptism²⁴ and on 25 Aug 1779 Luke Hanks was received²⁵.

On 14 October 1779 Luke Hanks signed a petition to move the courthouse (Pr. Wm. Co.) from Dumfries to the land of John Randolph near Butler's Ford.²⁶

The will of Robert Dale in Pr. William Co. dated 7 February 1778 names wife Elizabeth, Robert Dale son of Reuben Dale, Lilley Dale daughter of brother Thomas Dale, Abraham Dale, Lucy Smith, 160 ac. where I now give to Luke Hanks after death of wife Elizabeth, rest of estate that is not already devised equally divided between William Dale, Luke Hanks and Isaac Dale and their heirs...after my wife's decease.²⁷

Note: *The heirs named in Robert Dale's will include a nephew, a niece, possibly a brother Abraham, Lucy Smith may have been a sister, William Dale and Isaac Dale may also have been brothers and Luke Hanks. Luke's mother Elizabeth Hanks may have been a sister of Robert Dale. Robert's widow Elizabeth Dale married Thomas Evans and Luke Hanks sold him the 160 ac. in 1784. Phyllis Winthurst who researched John Hutchison says John Hutchison and Robert Dale were tenants of Cuthbert Bullitt on Kettle Run, Pr. William/Fauquier Cos. and that Isaac Dale, living in Shenandoah Co. sold his rights and interest in this estate.*

1782 Prince William Co., VA. Personal property tax list have Luke Hanks on John Tyler's list with 1 wm21, 0 wm 16-21, 0 blacks, 2 horses, 6 cattle²⁸ The 1783 Pr. William Co., Va. tax lists - Luke Hanks with 1wm 21, 3 horse, and 7 cattle.²⁹ There are no Hanks on the 1784, 1785 or 1787 tax lists.

Know...I Luke Hanks of Pr. William Co. sell to Thomas Evans of same all the reversion of that estate given and bequeathed by Robert Dale late of county deceased in LW&T dated 7 Feb 1778 after death of then wife of sd. Robert...which estate is now in possession of sd. Thomas Evans by virtue of his marriage to the widow Elizabeth Dale...dated May 1784 and ack. 2 Nov 1784 by Luke Hanks, witnessed by Dixon Robinson and James McLandham.³⁰

12 Feb 1785 – Turkey Creek Baptist Church Abbeville SC – brother Luke Hanks and his wife, Nancy Hanks, place letters of membership.³¹ From 1785 to 1804 Both Luke Hanks and his wife Nancy are on the church rolls.³² * August 1787 Mrs. Ann Hanks, wife of Luke Hanks, was disowned and excluded for disorderly conduct and speaking disrespectfully of the brethren.³³ *Note: Ann Hanks became a Methodist and was very vocal in her practice of this religion.* June 1789 Luke Hanks deceased.³⁴

Legislative Petition of Pr. William Co. 21 Nov 1788 Merchants and Freeholders of the Town of Dumfires and County of Prince William petition the House of Delegates to establish a tobacco inspection

warehouse on the lands of Cuthbert Bullitt in or adjoining the town of Newport, signatures include Luke Hanks, William Harding, Cuthbert Harding, Joseph Combs, Cuthbert Combes, Fielding Combs and Ennis Combs.³⁵ (Note: *This Luke Hanks cannot be Luke Hanks III as he had migrated to South Carolina by 1785. This may be Luke Hanks born by 1769, a son of Abraham and Jemima Million Hanks. He later migrated to Halifax Co. NC and Knox Co. Ky.*)

Luke Hanks of Pr. William Co. is believed to be the same as Luke Hanks who married Anne Harris/Harrison about 1767 and migrated to Abbeville SC. Children included: Thomas 1768, Martha Ann 1770, Nancy 1772 married Mr. South, Luke 15 Oct 1774, Elizabeth 1776 married Mr. Haynie, Susan 1778 married Charles Haynie, Lucretia 1780 married Solomon Pruitt, Robert 1782, Judith 1784 married Haynie then Hall, George 1786, John 1788, and Priscilla married William South. Notes: Most of the material on Luke Hanks and family of SC comes from Leonard Andrea files, South Carolina Archives.

The 1790 Anderson Co., SC census shows Mrs. Ann Hanks with 6 females and 5 males. Daughter Martha was married by 1790 and the rest of the children fit the census.

The 21 May 1789 (probated 7 Oct 1789) will of Luke Hanks of Abbeville SC. names wife Anne and all children to share.... This estate did not clear probate until 1838 at the death of wife Anne/Nancy Hanks. Part of the estate was acreage from Anne's brother Col. Harris. The children named in the settlement include: Thomas, Luke c. 1775, Robert, George, John, Elizabeth, Martha Ann c. 1770, Priscilla, Nancy, Judith, Lucretia c. 1781, and Susan.

From the Pendleton Messenger: Miss Eliza Ann Hanks, a daughter of the widow Hanks married 28 Sept 1841 to Quenton Loveless.

Abraham Hanks (Luke II, Luke I, William) 1743 – 1783/85 – Note: *According to Baber, Abraham Hanks married Sarah Harper and had Abraham born 1770 and married 1792 Polly Combs in Caswell NC, Luke Hanks born 1771 married Celia, William Hanks born 1775 married Margaret Wilson and Eliza. Loyd, George Hanks born 1782 married Sibby Harper, Fielden Hanks born 1783 married Lydia Harper, Nancy Hanks born 1784, John Hanks born 1786 married Amy Swift, Sarah Hanks born 1788 married James Hanks then Andrew Varvell and Mary Hanks 1790. Mary Hanks (Luke II, Luke I, William) born about 1745 and married first Jonathan Weldon (1740-1781) and second William Pearman (1730-1788). See the website: Descendants of Jonathan Weldon and Mary Hanks for information on the descendants of this couple.

“We are the descendants of Jonathan Weldon and Mary Hanks who were united in marriage about 1763 in Pittsylvania County, Virginia. Most of the information on this site has been contributed by individual families which have descended from this couple. If you discover that you belong to this family line, please contact us. We enjoy hearing from all our cousins and especially appreciate any additions or corrections to what we have recorded.”³⁶ (The Rootsweb site where this information was found is no longer available. Rootsweb was purchased by ancestry.com and is no longer unavailable.)

“Although no records document the exact year Jonathan came into this country (Pittsylvania Co. Va.), his first recorded land acquisition involved a grant of 804 acres on the waters of Lower Double Creek. Jonathan Weldon's grant in the southeast corner of the county was first surveyed for Nathaniel Hughes on

12 February 1766. Whatever interest Hughes had in the property was assigned to Jonathan Weldon through a grant issued by Governor Thomas Jefferson on 14 June 1780. Weldon paid 80 shillings to the Commonwealth for this grant. Adjoining property was owned by Thomas Walkins, Charles Weatherford, and Henry Tally. The farm was located between Kentuck and Laurel Grove."³⁷ His land was toward the end of present Highway 711, also called Slayton Road off Route 729."³⁸ Jonathan Weldon grant of 804 ac. on Lower Double Creek Halifax Co., Va. 14 June 1780.³⁹

"The 1903 family history by William Gray Welden SKETCH OF THE WELDEN FAMILY, states that all of Jonathan Welden's (Weldon) children were born in Pittsylvania County and that he had three sons; Isaac, Beverly, and Jonathan (II), the latter son born in 1776. This history indicates there were at least three daughters; Susan, Sallie(Sarah) and Frances, and that during the Revolutionary War the two oldest sons left home; Beverly Welden moving to a northern state and Isaac Welden moving further south."⁴⁰

"In a will signed by Jonathan Weldon, on 18 Dec 1781, and still on file at the Pittsylvania County Court House, shows that the three sons were Isaac, Jonathan (II), and William Dale Weldon. Six daughters were named; Susannah, Frances, Elizabeth, Sarah (Sallie), Mary, and Lida (Lydia). Also, Jonathan Weldon did not reach Pittsylvania County until after his marriage to Mary Elizabeth Hanks, therefore some of the elder children may have been born elsewhere. Jonathan's will was witnessed by four of his neighbors, which included John Creel (who was the pastor of the oldest Baptist church--Kentucky--that is still active in this Virginia county) and John Henry, a cousin of Patrick Henry."⁴¹

"Following the death of her husband, Jonathan's widow married a second time to William Pearman. After the death of her second husband, Mary Elizabeth moved to the Abbeville District of South Carolina by 1806."⁴²

Will of Jonathan Weldon Vol. 11, page 129, 18 Dec 1781⁴³ of Pittsylvania Co. Va. names wife Mary Weldon, sons Isaac Weldon, William Dale Weldon, daughters Susanna Weldon, Frances Weldon, Elizabeth Weldon, Sarah Weldon, Mary Weldon, Lida Weldon. Executors were wife and Moses Hanks and John Waller. Witnessed by John Creel, James Adams, John Pond and Foran (Fortunatus) Dodson.

Probated 15th day of Oct. 1782, by Mary Weldon, the Executrix therein named, giving security with John Pond and James Adams.⁴⁴

After the death of her second husband, William Pearman, Mary Elizabeth moved to the Abbeville District of South Carolina. There were several Hanks families in that area and perhaps she was related to some of them.⁴⁵

Her children include:

Winifred Weldon was born 29 December 1761 in Richmond County, Virginia.⁴⁶

Susannah Weldon was born on 9 May 1765 in Pittsylvania County, Virginia.⁴⁷

Isaac Weldon was born about 1768 in Pittsylvania County, Virginia. Isaac appears on the 1800 Abbeville, South Carolina census.⁴⁸

Mary Weldon was born about 1769 in Virginia.⁴⁹

Elizabeth Weldon was born about 1770 in Pittsylvania County, Virginia.⁵⁰

Sarah/Sallie Weldon was born about 1772 in Pittsylvania County, Virginia.⁵¹

Jonathan II Welden was born in 1776 in Pittsylvania County, Virginia and died in 1844 in Linwood, Hart County, Kentucky, at age 68.⁵²

Lydia Weldon was born in 1778 in Pittsylvania County, Virginia and died before 1860 in Cherokee County, Alabama.⁵³

Frances Weldon was born about 1779 in Pittsylvania County, Virginia. Frances married Nathan Pearman.⁵⁴

William Dale Weldon was born in 1781 in Pittsylvania County, Virginia and died on 28 May 1860 in Hart County, Georgia, at age 79.⁵⁵

Moses Hanks (Luke II, Luke I, William) born about 1747 married Agatha Dodson and had Mary 1776, Moses 1779, Elizabeth 1782, and others. From: Michele Ule on Rootsweb – Dodson Family— “Agatha Dodson Hanks' birthdate is by deduction. Her son Rev. Thomas Hanks' family Bible lists Moses Hanks' birth as July 15, 1748. Directly underneath is written ‘His wife December 1749’. Agatha is not named, but she was his only wife. Incidentally, we recently deduced her death year--from my Hanks paper:”

"According to [Gladys Hanks] Johnson, Agatha's death date is not known owing to a torn page in Elijah Hanks' Bible. She is said to have died in November. A letter written in 1922 from Isabel "Belle" Hanks Posey stated "Agatha Hanks was born in December and lived to the age of 87 years", which means Agatha would have died about 1835".

Waldrop of Murray, Kentucky found in an old Bible of her grandmother, who was the wife of William Reuben Hill an old piece of foolscap paper upon which was a list of names. William Hill was a grandson of Joiasy Hanks who is the daughter of Moses Hanks of Virginia. The paper contains two lists of names without surnames, but it is known from family records and letters that the list of names under Thomas are the sons of Thomas Hill and the other list under Luke are the sons of Luke Hanks.”
